1. *Crime and Patrol Summary*

See attachments. The department responded to 936 requests for service during the month of January. Community Service responded to 85 requests for service.

Calls for service were steady for the month, the patrol division was busy. The Officers handled several DUI arrests, illegal drug possession arrests and domestic violence cases.

This month several Officers from the department were praised by a victim of abusive relationship. Corporal Bryan Gonzales, Corporal Alvin Luker, Officer Josh Martinez, Investigator Travis Young and Moffat County Deputy Baker received a letter from a female victim of Domestic Violence. She thanked the officers for helping her leave a “physically, verbally and emotionally abusive relationship”. She also stated that “you save a life that day and gave my life back to me. You are a crucial part of this community in Moffat County, Craig, Colorado.”

I am truly grateful that the victim in this case took the time to write a letter of thanks to our officers. Receiving this type of positive feedback is very much appreciated. Domestic Violence situations can be very complex and difficult to handle. I am proud of the officer's efforts

5. *SRO Activity*

Officer Rimmer and Officer Fritz started to teach the DARE curriculum to the Ridgeview and East Elementary 5th grades. This year we are also teaching DARE at Calvary Baptist for the 5th and 6th graders there.

Officer Fritz remains working patrol shifts in order to cover our personnel shortfall, he has been working within the school as call loads allow in order to stay involved with the schools and school activities

Officer Rimmer was involved in the following activities for month.

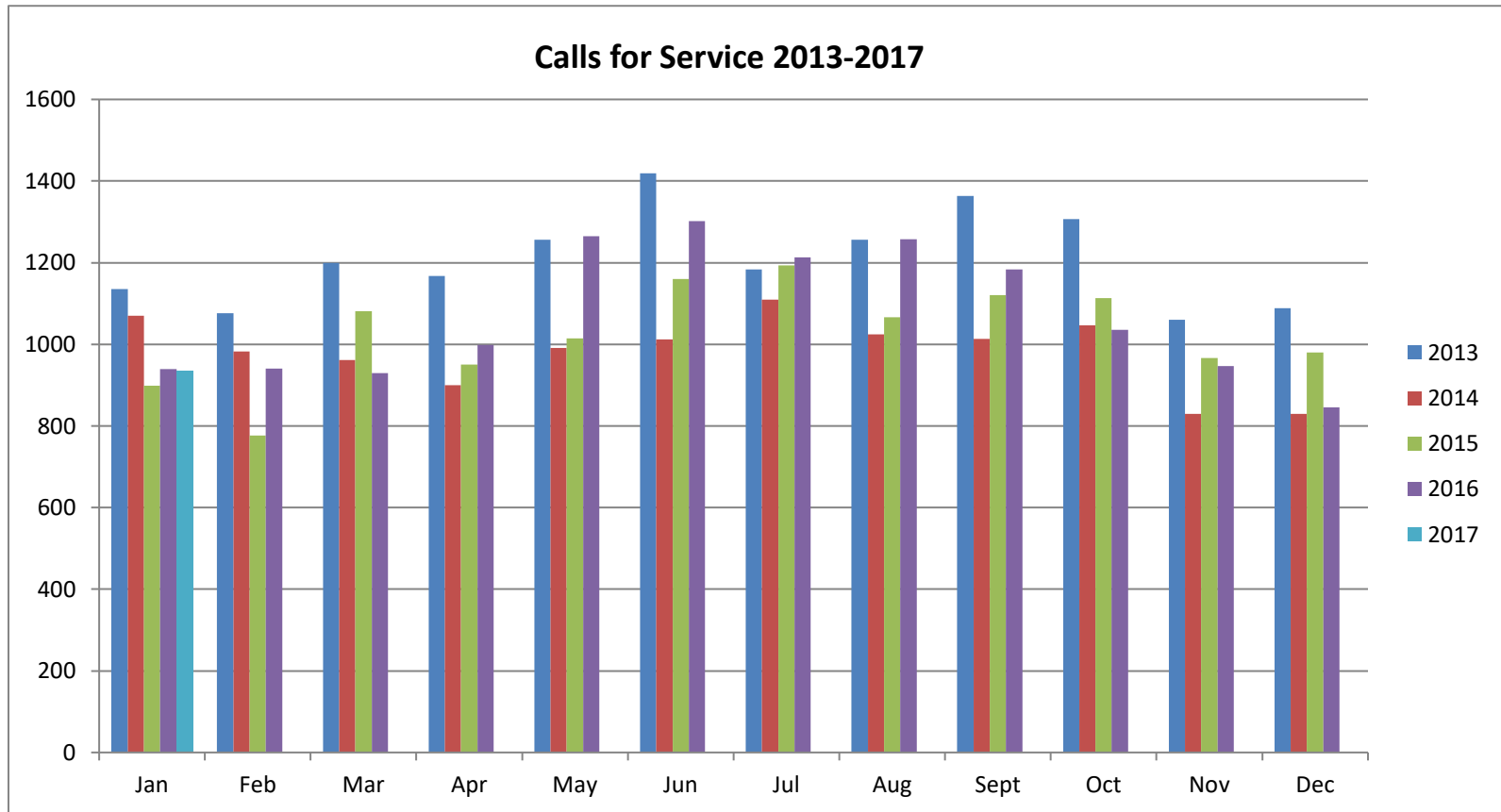
