1. Crime and Patrol Summary

See attachments. The department responded to 1,221 requests for service during the month of June. Community Service responded to 165 requests for service.

The trend of vehicle thefts continued this month, as we responded to numerous thefts from vehicle calls.

There was an increase of shoplifting complaints also. We investigated an employee theft from a local business. The employee was alleged to have validated numerous gift and Visa cards for a total over \$3,000 without paying for any of the cards. This individual was arrested and charged with theft.

We had several arrests for violation of restraining orders. Most of them occurred when the restrained person violated the alcohol restriction of the order.
