## 1. *Crime and Patrol Summary*

*See attachments. The department responded to 941 requests for service during the month of January. Community Service responded to 82 requests for service.*

*This month there were over ten individuals arrested for warrants. Several of these individuals had more than one warrant for their arrest. The majority of the warrants were Failure to Appear and Violation of Court Orders.*

*Patrol is following up on a bad check case at a local merchant. An individual wrote several bad checks for over nine thousand dollars in merchandise. The officer is in the process of obtaining documents from the financial institution to complete the investigation.*

### *4. Investigations/SRO Activity – Captain Bill Leonard*

*Investigations Sergeant Brian Soper has resigned from the department after over 20 years of service to our community. Brian started with our department as a patrol officer, was promoted to patrol sergeant and within the last year transferred to Investigations. Brian's community outreach, law enforcement knowledge, leadership and high integrity will be greatly missed. We will be thanking him for his service on February 6 at 1:00 pm at the Council Chambers.*

*On December 10, 2018, all three officers of the Rangely Police Department were involved in a fatal officer involved shooting in Rangely. Because their entire department, including their two supervisors were involved in the incident; the Town of Rangely needed an outside agency to complete their internal investigation of the incident. Both CIRSA and the Town Manager of Rangely requested our agency to do the investigation. City Manager Brixius agreed to have our agency complete their investigation. Sergeant Soper, Investigator Doug Winters from the District Attorney's Office and I handled the investigation. We completed our investigation on January 22 and provided our findings to the Rangely Town Manager, Mayor and Attorney.*

*The investigation into the Christmas Eve fatal fire involving a three-year-old victim is now complete. At our agency's request, we had a fire investigator from Colorado Division of Fire Prevention and Control assist with this investigation. Our investigation found that the 3-year-old died as a result of the fire. The fire started in the room where the three-year-old was located. Considering items found near the three-year-old and information learned during the investigation, we believe the three-year-old started the fire as a result of child fire-play. Our investigation will be sent to the Fourteenth Judicial District Attorney's Office for review. This case involved numerous requests for information from media sources around the state. We also want to say a heartfelt thank*

*you to everyone who supported our staff while they worked this tragic event over the holidays. Many neighbors who live in the area brought food, refreshments, hugs and encouragement when it was most needed - even at 4:00 am! We are touched by the kindness shown to us and appreciate all of the thoughts.*

### *School Resource Officer Report*
