1. Crime Summary

See attachments. The department responded to 998 requests for service during the month of April. Community Service responded to 141 requests for service.

3. *Miscellaneous*

On April 7th, Detectives Norm Rimmer and John Forgay did a bank presentation at the Bank of Colorado on Robbery Prevention and Active Shooter Response for fifteen employees.

April 16th and 23rd, the SAPP Pancake Breakfasts took place at McDonald's. Several department employees volunteered to help.

April 30th, the Craig Police Department, Colorado State Patrol and the Drug Enforcement Administration are partnering to host the Drug Take Back Day from 10:00 am to 2:00 pm at the Centennial Mall parking lot. Unwanted prescriptions will be collected and disposed of free of charge. 78 pounds were collected.



April 26th during the City Council meeting, I was honored to present Mr. Rich Sadvar with the department's Citizen's Meritorious Service Award. On April 8th, while driving down Yampa Street, Mr. Sadvar witnessed a male subject attacking two females with a bat. He stopped and put himself in harm's way to stop the assault. His actions minimized the injury to the victims and aided law enforcement in quickly and safely apprehending the suspect. As one officer said "Thank God there are still people out there who care enough to risk their own safety to help others in need!" On behalf of the Craig Police Department, we thank him for his bravery and willingness to take action.



April 30th, several members of the Craig Police Department participated in the Celebrate Children's Festival at the Centennial Mall. The festival was all about children 8 years old and under. Our participation was geared towards safety.

4. *Investigations - Commander Bill Leonard*

Beginning with this monthly report, Commander Bill Leonard will include a section on the activities of our Investigations Division.

- *On March 29th, officers were called to an assault call at Frontier Apartments. On arrival, officers found that two adult males had been involved in an argument in one of the apartments. The argument escalated to one of the males stabbing the other male in the neck and chest. The victim was initially transported to Craig Memorial Hospital, and then was transferred to St Mary's Hospital with life threatening injuries. The other male was arrested for First Degree Assault. The victim did survive and has since been released from the hospital. The case remains under investigation.*

May 28th, department personnel will assist with Moffat County High School graduation.

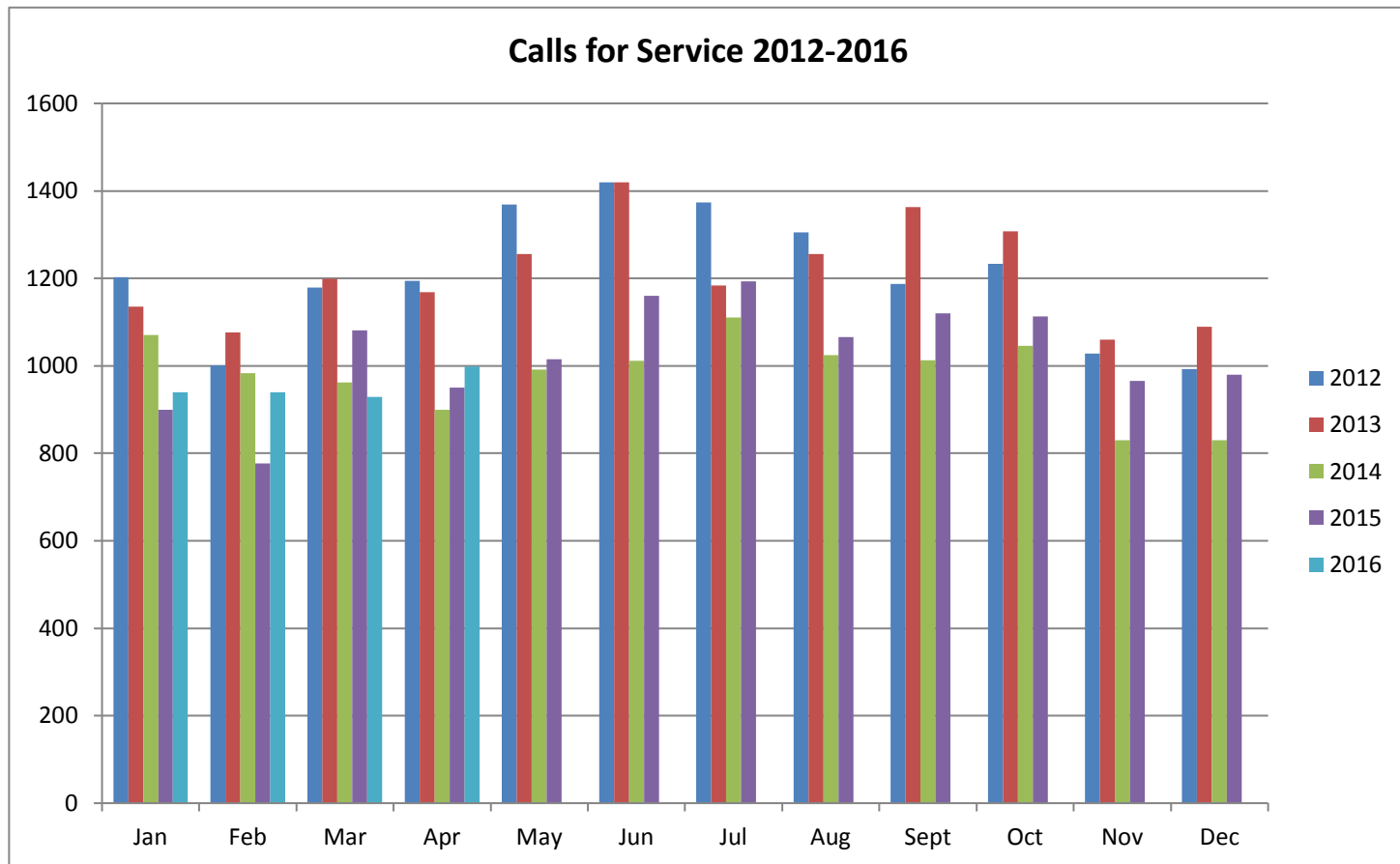
