*In 2015, there were 19 DUI arrests from January through April. This year, there were 30 DUI arrests from January through April; a nearly 58% increase over 2015.*

*As you can see in the Investigations area, patrol officers responded to five death scenes in two days. The impact of these on the officers is substantial and requires a great deal of resilience.*

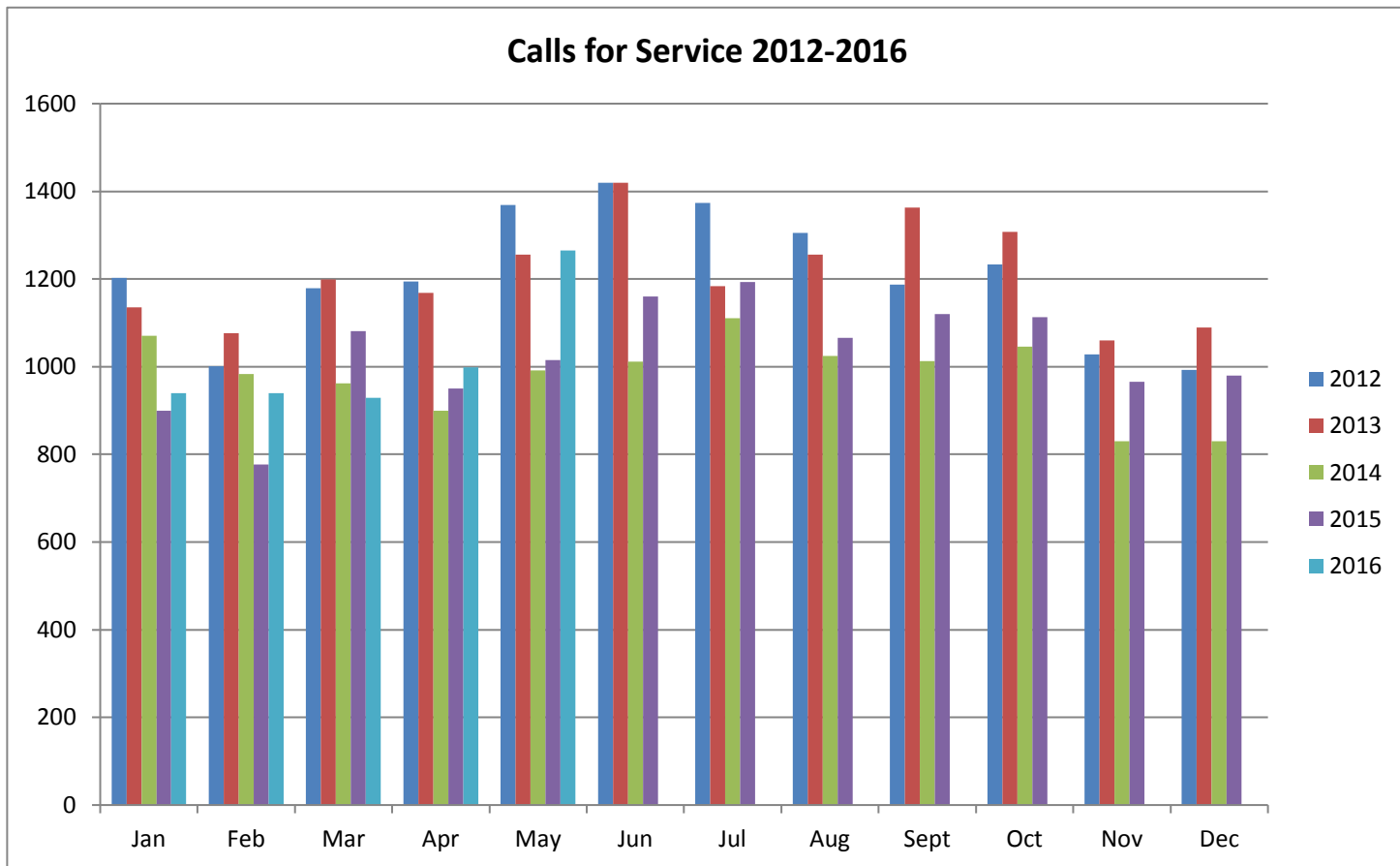
